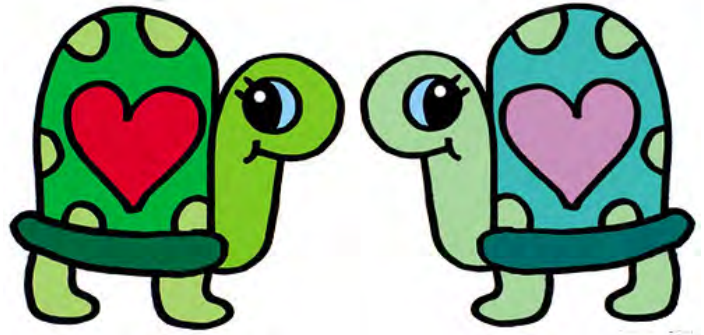

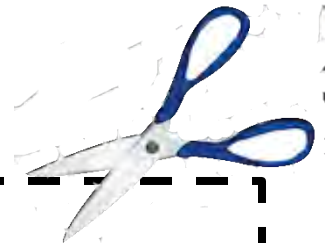

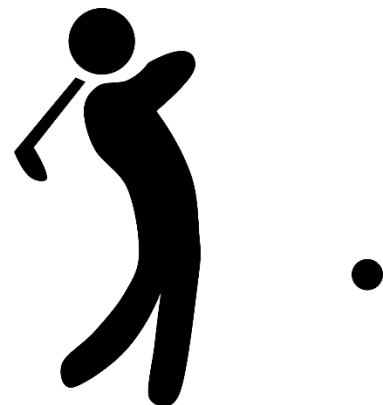

## Bocce Time is Here Again



The 2020/2021 Bocce season is once again about to start.

As we have done over the past several years, your team (4 players) will be selected each week by a lottery drawing. We have found that over a period of the season, every player will have the opportunity to play with everyone at least once.

We will schedule two primary days. These days will be Monday and Thursday afternoon starting at 1:00 PM. We will play 2 games, if needed we will play a tie breaker third game.

If you have played Bocce outside of Gull Aire, you may have played with different rules then what we use here. We will play with the Documented Gull Aire Bocce Rules.

Bocce Sign Up sheets will be posted on September 20. These sheets will be for Monday and Thursday. Each of these days we will have 16 sign up spots. We will also post an overflow sign-up sheet for either Tuesday or Wednesday.

If you are willing to be a substitute, please sign up on the Sub Sheet for either or both days.

The rain and summer heat is brutal on our Bocce Courts and requires that we put new Hard-Tu down to resurface the courts every couple years. We are all getting older and we need some more individuals (men and woman) to help do this. The current plan is to have the Hard-Tu delivered around the end of September and put it down a day or two later (dependent on supplier's schedule). 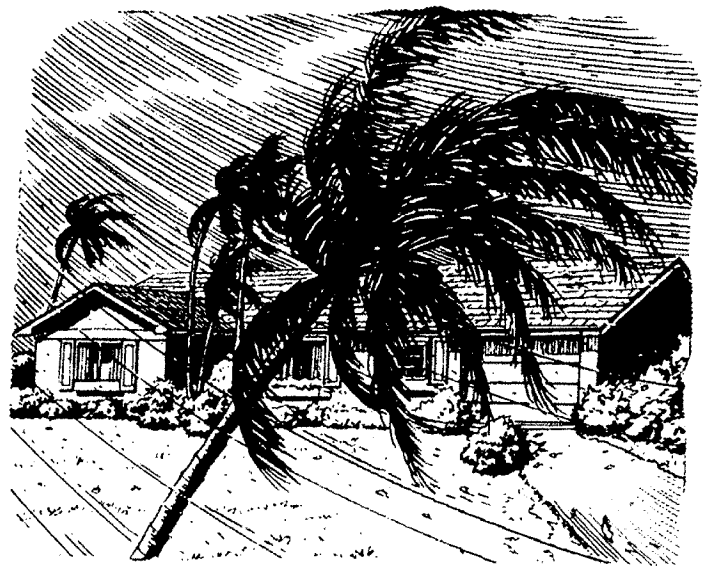
